## 5 Points to America's Freedom

## What is Real ID?

## WHAT IS THE REAL ID ACT?

The REAL ID ACT will require each citizen to carry a national identity card that is approved by the Department of Homeland Security (DHS). The REAL ID ACT was added on to an \$82 billion military spending bill for our troops in Iraq and some charitable relief for the Tsunami disaster. Because all the attention was focused on the war effort, the REAL ID ACT was added without any debate and very little discussion and passed with little opposition. Beginning in May of 2008 you will need a new drivers, or non-drivers license identity card before you can board a federally regulated aircraft, enter a federal building, a nuclear power plant, open a bank account or participate in any federally regulated/funded program.

## HOW DOES THE CARD WORK?

The new ID card will have a "common machine readable technology," that will hold far more data about you than what is on the front of our ID card now.

To get your new drivers, or non-drivers license, you will have to present your social security card, original birth certificate, proof of residency and a photo identity document. All of these documents will be digitally stored and put in the state data base and shared with all other states and federal agencies. (Practically speaking, your driver's license likely will have to be reissued to meet federal standards.)

## IS MY INFORMATION PRIVATE?

The card will be an electronic means of storing an individual's personal data which could be accessed by card reading scanners. Anyone with enough knowledge can download your data without you even being aware of it. The DHS now wants to share this data globally with the countries that potential terrorists could come from.

## HOW MUCH WILL IT COST ME?

It is estimated by the federal government that the program will cost \$23 billion dollars which will have to be absorbed by the individual states since this is an unfunded mandate. The REAL ID ACT hands the DHS the power to set these standards and determine whether state driver's licenses and other ID cards are acceptable.

We have had many great leaders who have stepped up in history by protecting the constitutional rights and freedoms that have made this country great. They are big shoes to fill, but it is my belief that every legislator who has rebelled against the federal government to

protect its citizens is carrying on the tradition. I have formed a coalition of states to oppose this REAL ID ACT and other threats to our freedoms.

## HOW CAN WE STOP THE REAL ID?

This coalition is LEGISLATORS AGAINST REAL ID, or LARI. LARI is committed to push legislation that helps the citizens of the United States.

This nation was formed to provide its citizens with individual rights and freedoms.
